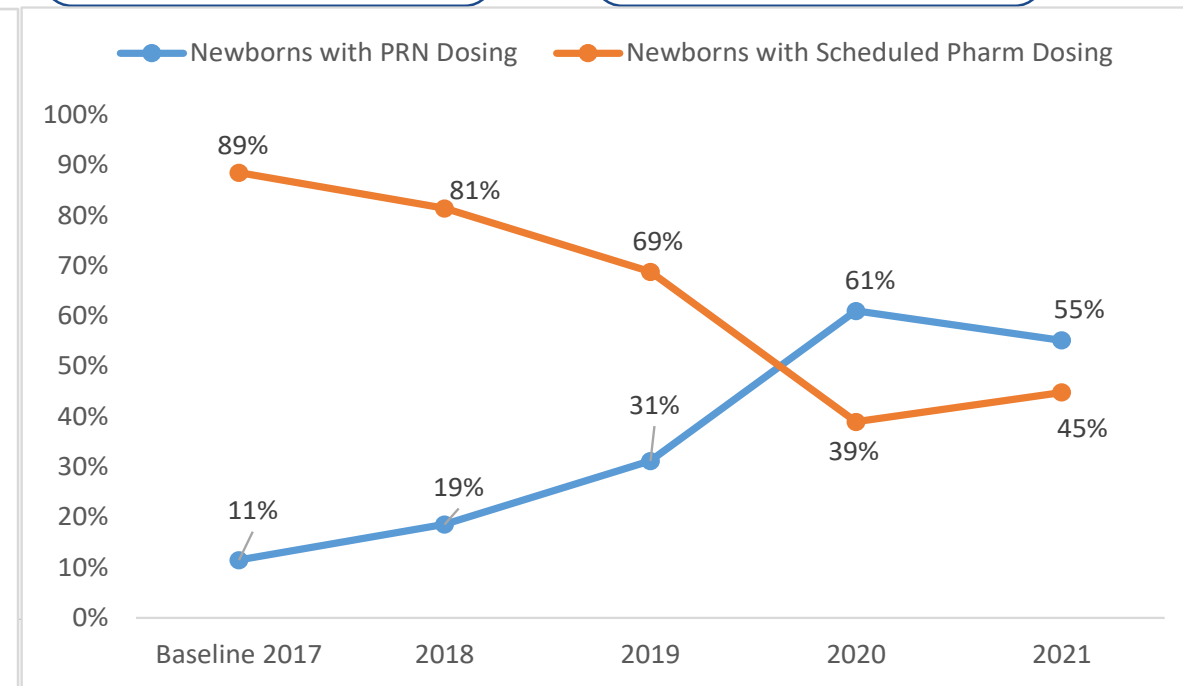
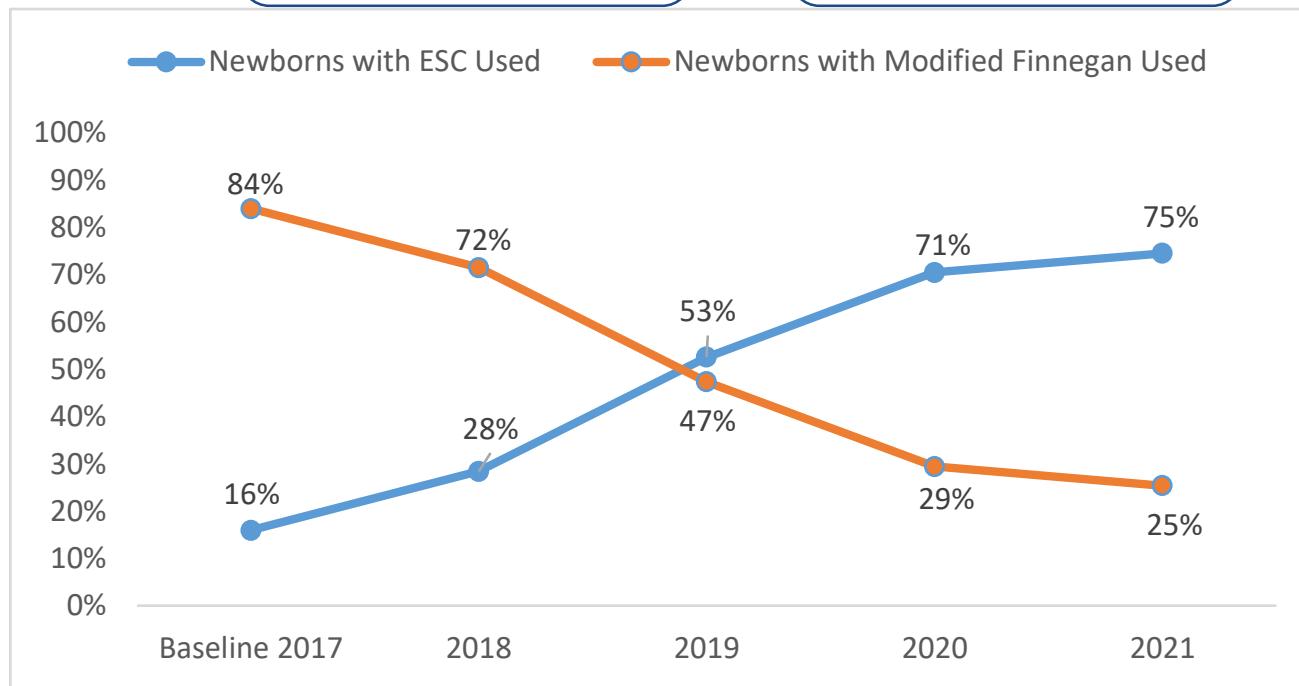

MNO's Impact: Length of Stay

- Teams have cared for over **2,034 Opioid-Exposed Newborns**
- Average Length of Stay for OENs with NAS symptoms is **3.8 days shorter**

Length of Stay for OENs with NAS Symptoms



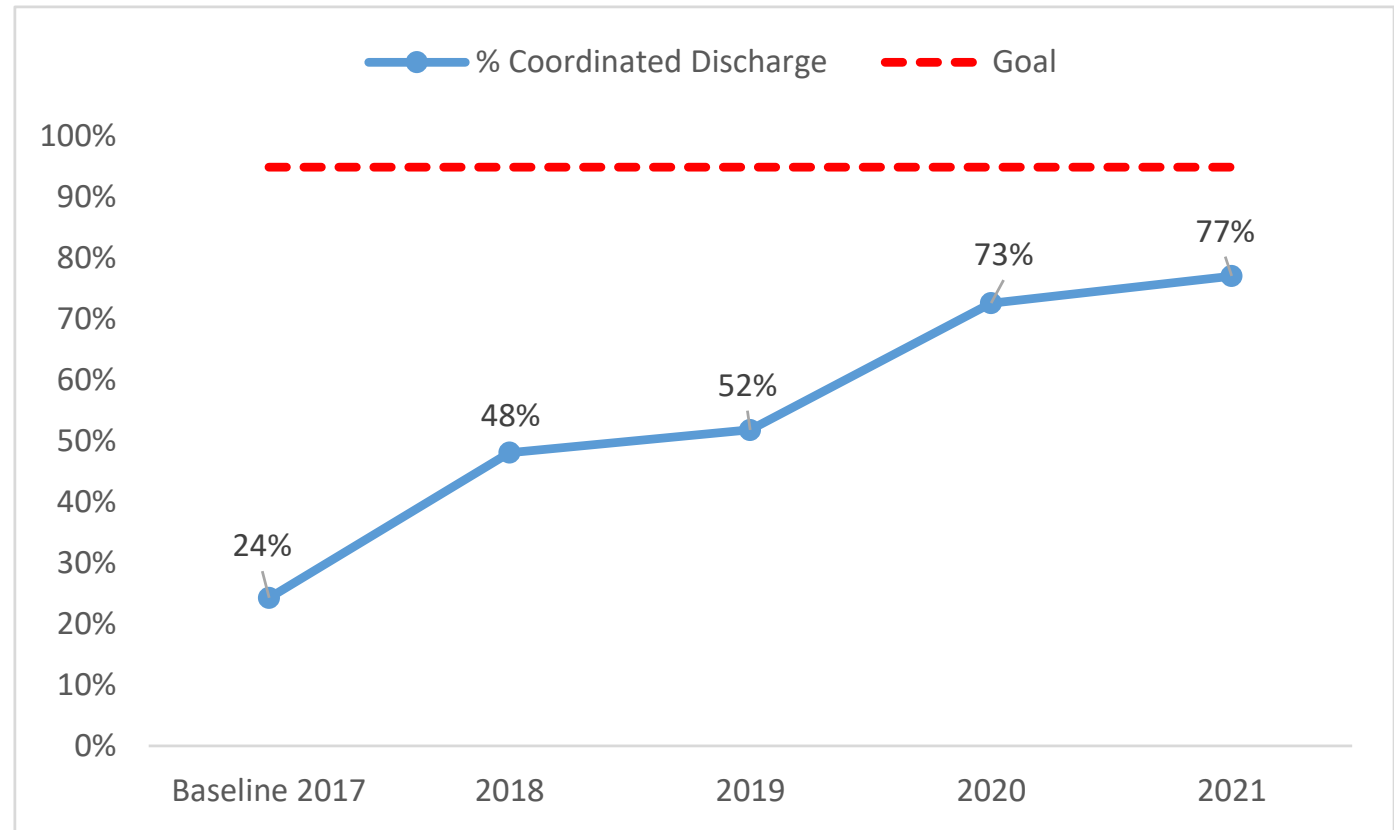
